

### The Chapels Royal of St Peter ad Vincula and St John the Evangelist HM Tower of London

#### Dear friends,

You will by now have learned of the resignation on 12th November of the Most Reverend and Right Honourable Justin Welby as Archbishop of Canterbury. This followed the publication of Keith Makin's 'Learning Lessons Review' of the activities of the late John Smyth QC, who committed horrific abuse of boys and young men under the guise of evangelism. That document is 253 pages long but merely reading the Executive Summary is sufficient to leave the reader in no doubt as to the gravity of the crimes committed by a man claiming to be winning souls for Christ. This was a canker at the heart of the Church of England and it is clear that a number of people, some of them senior, were complicit in covering up his deeds and encouraging him – if not actively assisting him – in his flight to Africa. There he continued his activities as before, first in Zimbabwe and then in South Africa, until his death in 2018. As Archbishop Justin has made clear in his resignation statement – and the Makin document does not conflict with this claim – he became aware of the nature and extent of Smyth's activities only in 2013. As he says in his resignation letter, "When I was informed in 2013 and told that police had been notified, I believed wrongly that an appropriate resolution would follow."

Archbishop Justin goes on to say, "It is very clear that I must take personal and institutional responsibility for the long and retraumatising period between 2013 and 2014." I suspect I shall not be alone in reflecting that such an honourable decision stands in contrast to the behaviour of others in public life who have stubbornly resisted acknowledging responsibility not only for their errors of omission but also for their own deeds in office. This is an example that we might do well to take to heart. For now, let us pray for Archbishop Justin, his wife Caroline and their family and let us pray for the church as it learns from these events. Above all, let each of us commit ourselves to rooting out exploitation of the vulnerable wherever we find it.

#### Poem of the week - November by Thomas Hood

Thomas Hood (1799 - 1845) was a poet, publisher, editor, and humourist. The son of a bookseller, he was born in London and lived there for most of his life, with stints in Scotland and Belgium. Well-known for his puns and comic verse, Thomas also composed poems that drew attention to the social evils of his day. This poem is like a shaggy dog story, in that we are led along – at a brisk pace -with a series of verbless utterances, each of which begins with the word 'no' – 19 times in all. Then comes the final line - one word - which is, if you like, the punchline. The poem is in one sense just a joke but, at the same time, it contrives to describe remarkably compactly the atmosphere of a month that can indeed seem utterly negative.

Wreaths were laid by the Constable (who also read the Lesson), by the Yeoman Body and by other representatives of the Tower and of the armed forces. Hymns were sung by all present, while the Chapel Choir sang an anthem. After the service, members of the congregation gathered in the Chapel for tea, coffee and biscuits and we were glad to welcome some of the visitors who had joined us in the service.
