Thought for the day

John Bell in his book *Living with the Psalms* reminds us that there are only a handful of psalms of wisdom, and Psalm 32 is one of them. The psalm begins with the words '*Happy are those whose transgressions are forgiven, and whose sin is put away*'. This psalm is sometimes referred to as '*The Joy of Forgiveness*'. To me, this seems an interesting pairing as, in my experience, forgiveness has often been anything but joyful. Both the 0915 and the 1100 services have a place for confession and absolution. Both are important but at times I find the words of the Prayer of Humble Access found in the Book of Common Prayer even more helpful. "*We do not presume to come to this thy Table, O merciful Lord, trusting in our own righteousness, but in thy manifold and great mercies.*" These words are a valuable reminder that we cannot earn God's forgiveness and yet it is always forthcoming. Now that is a joy to hold in our hearts!

Poem of the week

Last week I travelled up north to the city of Durham to visit my 97-year-old mother. A few years ago, she needed to move into a nursing home because of failing eyesight and increasing deafness. While I was there, I popped into Durham Cathedral which is very close to where mum now lives. By chance, on the seat next to where I was sitting, someone had left a poem on a piece of paper. The poem was *A Sacramental Sparrow* by Maggie Jackson, an award-winning American author and journalist, best known for her pioneering writings on social trends, notably technology's impact on humanity. She was the winner of the 2020 Dorothy Lee Award for Outstanding Scholarship in the Ecology of Culture for her book *Distracted: Reclaiming Our Focus in a World of Lost Attention*. Her book *Uncertain: The Wisdom and Wonder of Being Unsure* is a recent best-seller. She lives with her family in New York.

I find something very moving in this poem. Perhaps it's because of the description of the strength and character of the sparrow compared with the size, power and wisdom of the other birds. Could it also be that important truths are transcended by the least expected? In Christian symbolism, the humble sparrow is an illustration of the inherent importance to God of the whole of creation, no matter how small or overlooked.

It should have been an owl, according to belief.

A Barn Owl with powerful wings
and wisdom in its eyes.

A bird whose stillness, when perched,
owns the attentiveness of an awesome God,
or a Buddha perhaps, deceptively sleeping,
transcending all in contemplation,
a silent counsellor for troubled souls.

But now, when wise listeners are absent,
It's not the Owl's attention I call upon,
Nor any God or mystical mentor.
It's a single Sparrow who sits on the birdbath,
Dipping its beak into the water of life.
Watchful of bigger birds who try to displace it.
Vitality clothed in a flutter of feathers.
Winged immanence communing with the world.
