Closer to home, please be aware that, with effect from Sunday 1<sup>st</sup> February, we shall again suspend services in the Chapel of St Peter ad Vincula while the next stage of work takes place – this time, on the roof. Therefore, from 1<sup>st</sup> February until at least the middle of March, we shall revert to having just one service each Sunday, which will be a service of Said Holy Communion in the Chapel of St John the Evangelist in the White Tower at 9.30 am. Once the roof work is complete, we should be able to revert permanently to our usual pattern of services.
